# Public consultation open on key guidelines and framework

Three consultations have recently been launched on revised guidance to help practitioners and others understand their mandatory notification obligations, understand their obligations when advertising a regulated health service and to support a responsive and risk-based approach to supervised practice.

The Board, together with other National Boards and AHPRA, are consulting on revised policy guidance on three major areas to replace current guidance, including:

- revised Guidelines: Mandatory notifications about registered health practitioners and Guidelines: Mandatory notifications about health students
- revised Guidelines on advertising regulated health services, and
- a proposed Supervised practice framework.

To ensure the community, practitioners and stakeholders have the chance to respond to all three consultations the closing dates for public consultation have been staggered and will close as follows:

- Public consultation on the mandatory notifications guidelines will close on 6 November 2019.
- Public consultation on the advertising guidelines will close on 26 November 2019.
- Public consultation on the supervised practice framework will close on 17 December 2019.

# Consultation open on blood borne viruses guidelines

The Board, in partnership with the Dental, Medical, Nursing and Midwifery and Paramedicine Boards of Australia, has opened consultation on the draft *Guidelines for registered health practitioners and students in relation to blood borne viruses* (the draft guidelines).

The draft guidelines are intended to support practitioners in these professions to comply with the Communicable Diseases Network Australia Australian national guidelines for the management of healthcare workers living with blood borne viruses and healthcare workers who perform exposure prone procedures at risk of exposure to blood borne viruses (the CDNA guidelines).

All registered health practitioners who perform exposure-prone procedures, or who are living with a blood borne virus, need to comply with the CDNA guidelines. The Boards have developed the draft guidelines to

support health practitioners and students to decide whether they perform exposure-prone procedures in their practice and if so, how to meet the requirements of the CDNA guidelines.

## Changes to renewal questions for podiatric surgeons

The Communicable Diseases Network Australia updated the *Australian national guidelines for the management of healthcare workers living with blood borne viruses and healthcare workers who perform exposure prone procedures at risk of exposure to blood borne viruses (the CDNA guidelines).* 

In response to the updates to the CDNA guidelines, the Board will be asking podiatric surgeons at registration and renewal whether they perform exposure prone procedures, and if so, to answer additional questions about compliance with the CDNA guidelines.

Podiatrists will not be asked these questions because the routine procedures undertaken by podiatrists, such as a nail avulsion, are considered non-exposure prone procedures.

The CDNA guidelines and helpful information sheets for practitioners, including information about exposure prone procedures and non-exposure prone procedures are available on the Department of Health's <u>website</u>.

#### The Board sets fees for 2019/20

The Board has frozen the registration fee at \$378 for the fourth consecutive year. The fee for practitioners whose principal place of practice is New South Wales is also \$378.
